MARK FOR THE *Future*

ALICE COUDRON ISN'T AFRAID OF HARD WORK.

Whether on her farm raising prize-winning Charolais cattle, in her community volunteering with charitable causes or acquiring her contractor's license to build condos, when she puts her mind to something, she's all in — mind, heart and soul.

Alice's passion for Catholic education started when she was a child. She attended public school in Foley and was released for catechism classes each week. Her parents always ensured that she and her siblings attended Mass regularly. When it came time for college, Alice knew she wanted to attend the College of St. Benedict in St. Joseph.

"My faith was that important to me," she recalled.

Alice received her degree in math and home economics. After college, she started a family and kept busy in her local community. She eventually went to work for Bauerly Brothers — her real-life brothers — and got her contractor and real estate licenses. The company was eventually bought out, and Alice was ready to seek out a new adventure — and she wanted to make sure it had purpose.

Ten years ago, she landed at the Catholic Foundation, a place where she knew she wanted to make a difference. She accepted the role as the consultant for planned giving and plunged head first into her work. She convened a focus group made up of Catholic school principals, priests and lay people who were also passionate about Catholic education. The group looked at the growing need — and the declining participation — for Catholic education in the Diocese of St. Cloud.

"We talked about the obstacles and the possibilities of what we could do to encourage people to support our Catholic schools and parishes," she said. "We were searching for a way to bring more enthusiasm to Catholic education."

Born from those efforts was a new endowed scholarship fund and a new event to help get it off the ground: "Breakfast with the Bishop."

The annual Breakfast with the Bishop began in 2014 and has raised more than \$360,000. The fund has given 634 scholarships and helped numerous families.

"It is humbling," Alice said. "And it is so encouraging, especially with the challenges in today's world. I feel that Catholic education offers students the opportunity to not only learn their faith but to have it integrated into their day. It becomes a part of them and a part of who they are."

While she feels that Breakfast with the Bishop has been one of the most successful venues for raising funds and awareness for Catholic education, she is also proud of the Bishop's Annual Golf Tournament, which has raised almost \$100,000 for seminarian education.

The foundation, whose original purpose was to house the Living the Promise funds from the campaign of the same name in 2004, supports Catholic education through parish faith formation programs. Grants are given to parishes annually and have exceeded distributions of more than \$2.5 million.

Alice said there also was a need for assistance for youth to attend faith-related retreats and, therefore, a fund called Generation Next was established to provide scholarships to youth and youth groups in the diocese. That sparked another idea — "Act-oberfest," a community-building variety show.

"It's a fun way we can bring people together," Alice said. "It's not meant to be a fundraiser, but more of a way for people to see the talent in our diocese and also learn about the foundation. A free will offering does benefit the youth-related scholarship funds we have at the foundation."

As Alice starts to think about retirement, she hopes she has left a mark on her faith community and she wants others to know that the Catholic Foundation can help others leave their mark, too.

"The foundation exists to pass on our Catholic faith to the next generation. That is the most important thing. All that we do and all that we are is to help grow people in their faith. With the challenges in today's world, we all need to participate to make the church alive, vibrant. We need to be encouraging and help people stick to their Catholic faith, especially during the hard times of life. If we don't do it, who will?"



LEAVING YOUR MARK THE “Betty way”



IN HER OWN QUIET WAY, BETTY KAMPA MILLER LEFT HER MARK NOT ONLY ON THE COMMUNITY HERE IN CENTRAL MINNESOTA, WHERE SHE LIVED FOR HER 84 YEARS OF LIFE, BUT ALL OVER THE WORLD.

Most knew her as a sister, a mother, a grandmother, a friend and a volunteer. Betty worked for St. Mary's Cathedral Parish for over 22 years. She was a proud supporter of all things Catholic and served as an officer for the Daughters of Isabella, volunteered with Befrienders, served as a eucharistic minister, greeter, served funeral dinners and sang in the choir. She also volunteered with Catholic Charities, the Serra Club, Christian women's group and hosted luncheons for the widowed.

In the community, she served at St. Cloud Hospital, St. Benedict's Senior Community, Whitney Senior Center, Meals on Wheels and at the Paramount Center for the Arts as an usher.

At the Catholic Foundation, Betty was often a voice at the table, quietly but firmly supporting Catholic education, specifically through her support of seminarians and Catholic schools by hosting a table each year at Breakfast with the Bishop.

Beyond St. Cloud, many knew her as their angel. In 2011, when her daughter Sue was struck with cancer, Sue began to make necklaces to raise funds and awareness for cancer research. Betty jumped right on board and began to make the necklaces, too, first for cancer and then expanding its reach to other charitable causes. Betty's daughter Kathleen Kampa Vilina, who works as a teacher in Japan, heard about the necklaces, requested some for her colleagues and friends there and the jewelry quickly became popular in Japan as well.

Betty began making the necklaces in large quantities in her free time and donated all the proceeds to various organizations. First, the funds helped build a home for a family in Guatemala. Later, the funds were used to purchase desks for a school in Africa.





"It's wonderful to see that my mom, who grew up here in Central Minnesota, that her influence is all around the world," Kathleen said. "Wherever people needed help, she always supported them."

Betty's granddaughter, Brooke Kearney, spent a lot of time learning from her grandmother and is excited that she, too, can continue the project Betty started now called, "Necklaces of Love."

"I think it's really cool that I can live out her legacy. She inspires me to do more," Brooke said.

"She lived simply but she lived big," Kathleen added. "She was always opening her heart and her door to everyone. I think that is really a sign of Christ's presence in her."

When Betty passed away in April 2019, the family went through her things.

"Every drawer had a crucifix in it — in her spice drawer, in her laundry room. Everywhere. She kept Christ at the center of all she did. She kept a list of those who had asked her to pray for them. She would pray for people at red lights. It's just all the little things. What would the world be like if we all decided to do things the Betty way?"

Kathleen likes to think that she is passing on the "Betty way" to her students in Japan by encouraging them to participate in random acts of kindness.

"I hope that when I talk about my mom and the way she lived her life, it will get them to start thinking outside of themselves. Just like her Necklaces of Love, in all she did throughout her life, stitch by stitch, she left her mark with love."

It was never about how much money she gave but about how much of her heart and soul she put into everything she did. Although her bright smile and encouraging support will be missed around the table and throughout the community, her spirit lives on through the legacy she has left behind in her family, her lifetime of Christian love and charity and her spiritual and financial generosity to the ongoing ministries she supported.



NEW FUND HELPS THOSE DISCERNING THE DIACONATE

LEAVING YOUR MARK IN

UNDERNEATH ALL THE HARDSHIPS, TRAGEDIES AND JOYS OF RITA REKER'S 54-YEAR MARRIAGE IS A LIFE BUILT SOLIDLY ON HER CATHOLIC FAITH.

When she met her husband Fred at a Catholic singles club in the 1950s, she knew he had another vocation in addition to marriage.

Since he was 17-years-old, Fred Reker felt called to serve the Lord. Growing up on a farm in southern Minnesota, five of his seven brothers left the farm to serve in World War II while Fred pursued the priesthood.

He was sent to a small mission school in New York run by the SVD and later the decision was made for him to attend seminary at St. Mary's University in Winona. He then transferred to St. John's University in Collegeville for more formation.

During that time his father passed away and Fred left the seminary. It wasn't until two-and-a-half years later that he met Rita. The couple eventually married and had six children.

Their married life wasn't too much different than other married couples they knew. They felt strongly about raising their children in the Catholic faith and sent them to Catholic school.

"We tried to give them as much Catholic education as we could. We had to live paycheck to paycheck for many years. And we got used to pinching our pennies," Rita recalled.

In 1974, tragedy struck. On Labor Day, two of their daughters, Mary, 15, and Susanne, 12, walked a few blocks from their family's home to buy school supplies. They never returned. Their bodies were found stabbed to death 26 days later in a St. Cloud quarry.

Rita said for her, her faith is what kept her going all these years. Not long after her girls' deaths, the first class of deacons was starting to form in the St. Cloud Diocese.

"It was just the worst possible time, but Fred just jumped right in and never looked back," Rita said.

Fred was ordained in 1978 by Bishop George Speltz and served as a deacon for more than 34 years before his death in 2012. He primarily served at St. John Cantius Parish in St. Cloud, and later to the cluster of St. John Cantius, St. Anthony's and Holy Spirit parishes. He also served as chaplain at the Foley Nursing Home for 19 years.

When Fred was in seminary, a priest helped with some of his educational costs and Fred, who died in 2012, always wanted to give back for the generosity he received. In 2018, Rita decided it was time to make that happen. That's when she established the Saint Stephen Endowment for Deacons, named after the patron saint for deacons.

"After Fred died, one thing I knew for sure was that I wanted to stay a part of the diaconate community. Fred had been ordained more than 34 years and that was such a big part of our lives, a big blessing of our lives," she said.

"Looking back, we had made some wise decisions regarding insurance and investments and once our kids were gone and our house was paid off, there was a little extra. After Fred died, there was some inheritance and that's when I decided I'd like to do something to help the deacons with their education," she said. "Some of them drive long miles just to go to classes. There's an investment there beyond the tuition."

Rita said that a deacon's vocation is really in service to the whole church.

"I really want to support them and their families and all they do for the Church," Rita said. "This isn't just a decision they made lightly. It is a vocation, a call from God."

I AM A "NUMBERS" PERSON, AND I WILL PROBABLY ALWAYS BE A NUMBERS PERSON. I LOOK FOR THE NUMBERS TO TELL ME THE STORY, BUT THIS YEAR YOU NEED TO HEAR "THE REST OF THE STORY..."

I grew up in a house that always had a radio on. It was on the same AM station that became the heartbeat for our family. One of the national personalities on this station was Paul Harvey, who had a number of different reports throughout the day.

In the morning, you knew that when Paul Harvey ended you had to be on your way to school or down the driveway to catch the bus or you would be late. One of the Paul Harvey reports each day was called "The Rest of the Story...". Usually, the story would start with something ordinary like a can of pop, a secret ingredient or the neighbor next door. There would be a commercial break, then listeners would come back to find out something extraordinary about the can of pop, the secret ingredient or the neighbor next door.

Reviewing the fiscal year-end financial reports for the Catholic Foundation reminded me of "The Rest of the Story...". The total investment amount is almost identical to last year, but this year it has been anything but ordinary. The stock market went up and down like a rollercoaster. We started new funds for parishes, schools, deacons and seminarians, and we received very generous contributions to existing funds.

We also had the joy of paying out scholarships and directing spendable funds to help educate students in faith formation, Catholic schools and those studying to be priests or deacons. Our total revenues and expenses were right on budget, but "the rest of the story" is that we spent more time and resources in parishes teaming up with pastors and outside companies to discuss end-of-life care decisions, estate planning, charitable giving and taxes.

For people like me who look to the numbers, these financials may seem pretty ordinary, but now you know the "rest of the story."
